WHEREAS, In 2015, the Bay County Health Department entered into a Memorandum of Understanding with Saginaw, Midland and Mid-Michigan District Health Departments to integrate the Fetch GIS system, a web-based geographic information system by Amalgam LLC of Mt. Pleasant, Michigan, for use by each department's environmental health programs; and

WHEREAS, The Health Departments wish to continue to share resources to obtain access to Fetch GIS, and continue to use Fetch GIS to identify parcels, environmental and constructed features and hazards and to map new construction for permitting; and

WHEREAS,	The position recently was moved from the judicial branch to the executive branch per the Michigan Indigent Defense Counsel (MIDC); and
WHEREAS,	The relevant experience of the employee and the unique circumstances surrounding the transfer of the position justify a request to hire the Office of Assigned Counsel Administrator at the PB05, 3 year step; and
WHEREAS,	The entry level of the PB05 pay grade is \$39,145.60 and the 3 year step (max) is \$44,478.40 per year. Funds are budgeted and no additional general fund dollars will be necessary; Therefore, Be It
