WHEREAS,	This project will increase security and safety during the grandstand and arena events; and
WHEREAS,	The BCFYE now has an opportunity to apply for a grant to help fund this project through the Michigan Department of Agriculture and Rural Development - "County Fairs Capital Improvement Grant Program"; and
WHEREAS,	\$30,000 is being budgeted for this project and the BCFYE would provide the 50% matching funds.
WHEREAS,	The following is a time line of the grant:

	Project/Program Duration: May 17, 2021 through December 31, 2021
	Final Reports Due: February 1, 2022
WHEREAS,	All improvements will be coordinated with the Department of Recreation and Facilities and, if a licensed contractor is needed, BCFYE will coordinate with Bay County Corporation Counsel and present the request to the Bay County Board of Commissioners for a third party contract approval; Therefore, Be It
