WHEREAS, The Bay County Civic Arena has two Munters units on the roof that control the humidity in each arena and their proper operation directly affects the quality of the ice; and

WHEREAS, The Bay County Board of Commissioners approved funds in the 2017 budget to have a Munters Service Technician come on-site for preventative maintenance and training and this took place on April 24th and 25th, a very informative two days for County staff; and

WHEREAS, Based on the service technician's evaluation, he has recommended the following: a replacement of the Olympic Rink desiccant wheel (last replacement was 2007), seals, and axle rollers; repairing the panel by the reactivation motor and the hastings heaters for both units; and purchasing certain monitoring tools; and

WHEREAS, Rental of a crane will be necessary to get the wheel on the roof; and WHEREAS, In addition, the gas company will be asked to increase the gas pressure coming into the building that feeds the units as the units are not getting to the satisfactory temperature currently; and

WHEREAS, As the technician was on-site, he was only able to estimate that the cost of these repairs be no more than \$26,000 (a more accurate estimate should be available before the full Board meeting and, if an adjustment of the dollar figure is needed, it will be submitted); and

WHEREAS, The needed repairs detailed above are estimated to cost up to \$26,000 and this project is not budgeted requiring a budget adjustment from the general fund; Therefore, Be It

RESOLVED That the Bay County Board of Commissioners approves an appropriation of up to \$26,000 from Fund Balance for these parts and repairs; Be It Further

RESOLVED That the Chairman of the Board is authorized to execute documents related to the project upon favorable review by Corporation Counsel; Be It Finally
