WHEREAS,	The contract holder is required to follow all food law/code; Therefore, Be It
RESOLVED	That the Bay County Board of Commissioners approves a contract between Bay County and Edward Lewandowski for a one (1) year term and authorizes the Chairman of the Board to execute said contract and related documents on behalf of Bay County following Corporation Counsel review/ approval; Be It Further

RESOLUTION

BY: WHEREAS,	PERSONNEL/HUMAN SERVICES COMMITTEE (5/15/18) The Board previously approved the County's request to put out an RFP for the Independent Contractor Position for Veterans' Affairs Officer, whose position is funded by the Veterans' Millage; and
WHEREAS,	After materials were submitted and interviews conducted, the RFP Committee selected Mark Kaczmarek as the new Veterans' Affairs Officer. Keith Markstrom, representing the Soldiers' and Sailors' Relief Commission ("SSRC"), participated in the RFP process and approved the selection; and
WHEREAS,	As per past practice, the Administrative Services Director and Finance Department for the County provide services to the SSRC by supervising that Independent Contractor and providing other administrative functions such as invoice processing, etc., which is attributed to the SSRC as indirect costs and is paid with millage funds; and
WHEREAS,	In order for the County to continue providing these services to the SSRC and also to provide the Finance Department with the necessary supporting documentation to process bi-weekly payments to Mr. Kaczmarek, it is necessary for the County to enter into an Agreement with the SSRC and Mr. Kaczmarek to formalize this past practice as well as Mr. Kaczmarek's Independent Contractor position as the new Veterans' Affairs Officer; and
WHEREAS,	There is no financial impact to the County, as the Veterans' Affairs Officer is paid from millage, rather than general fund, dollars, and the Agreement is simply documenting past practice of County Administration and formalizing the selection of Mr. Kaczmarek as the new Independent Contractor/ Veterans' Affairs Officer; Therefore, Be It
RESOLVED	That the Bay County Board of Commissioners approves the Independent Contractor and Supervision Agreement with Mark Kaczmarek and the Soldiers' and Sailors' Relief Commission (SSRC) and authorizes the Board Chair to sign said Agreement and related
