# **RESOLUTION**

BY:	PERSONNEL/HUMAN SERVICES COMMITTEE (6/18/19)
WHEREAS,	Earlier in the year Dr. Kanu Virani notified the Health Department of his desire for increased compensation as his contract and compensation has remained the same since 2006; and
WHEREAS,	In February, the Board approved an RFP/RFQ for Forensic Pathology services (Board Resolution 2019-24), which has subsequently been released and the submission is under evaluation by the review committee; and
WHEREAS,	While Dr. Virani had initially indicated that he would continue services under the existing agreement, he has since indicated that this contract is terminated under his requests from the January letter and that he will only perform services for Bay County at a higher rate; and
WHEREAS,	While the County has employed the services from other Pathologists to perform autopsies on an ad-hoc basis, the availability of these replacements is problematic and can be hard to procure; and
WHEREAS,	Utilizing the authority granted from the Emergency Purchasing Policy, it is in the better interests of the County to retain Dr. Virani's services until a permanent solution is formulated; and
WHEREAS,	Currently the cost to perform an autopsy is \$750 per case and \$400 for court testimony per case, however, given that this amount has not changed in thirteen years, it is considerably below the average cost in the State; and
WHEREAS,	Under the terms of the proposed agreement, Dr. Virani would be compensated at \$1,200 per case for autopsy services provided, \$1,200 for court testimony per case, as well as coverage for general liability and, with this increase, it is still consistent with amounts paid to Dr. Virani by surrounding communities (Saginaw, Midland, Huron, Tuscola Counties, etc.); and
WHEREAS,	The Health Department has diligently monitored the Medical Examiner budget and at this current date, only one-third of the budgeted amount has been expended so, at this time no additional funds to cover the anticipated increased costs are requested; Therefore, Be It
RESOLVED	That the Bay County Board of Commissioners approves the Temporary Agreement with Dr. Kanu Virani to Continue Forensic Pathology Services and the Chairman of the Board is authorized to sign said Agreement on behalf of Bay County (Health Department) following Corporation Counsel review/approval; Be It Further
