BY:	PERSONNEL/HUMAN SERVICES COMMITTEE (6/14/2022)
WHEREAS,	On June 1, 2022, the Bay County Courts received notice that the Michigan Supreme Court mandated that all Michigan Courts observe Juneteenth as a Federal Holiday; and
WHEREAS,	Subsequently, due to this mandate, the Court will be closed on June 20, 2022, and the staff are working diligently to reschedule activities scheduled for that day on short notice; and
WHEREAS,	In an effort to offer consistency and equity, all Bay County buildings will observe Juneteenth by closing operations as it would other federally recognized holidays; and
WHEREAS,	The Personnel Director will engage in reaching out to the 13 bargaining units to reach a letter of understanding to add this to the current collective bargaining agreements; and
WHEREAS,	The additional cost to the County, due to 24/7 facility operations, is estimated at \$50,000 annually; Therefore, Be It
RESOLVED	That the Bay County Board of Commissioners approves amendment to the current collective bargaining agreements to add Juneteenth as a Federal Holiday; Be It Further
RESOLVED	That related budget adjustments, if required, are approved.
