WHEREAS,	The majority of the golf cart fleet at the Bay County Golf Course is over 10 years old and the golf carts have reached a point where major repairs and maintenance are required; and
WHEREAS,	In an effort to reduce labor expense quoted at \$13,440 for outside golf cart repair, Bay County's Buildings and Grounds Department will repair the carts in-house at a projected savings of \$3,040 and the Golf Course will continue to lease 10 additional golf carts from Titan (a budgeted expense in 2013) during the busiest 4 months of the golf season; and
WHEREAS,	A \$10,400 budget adjustment within the existing 2013 golf course budget to repair 28 existing golf carts is required; Therefore, Be It
RESOLVED	By the Bay County Board of Commissioners that a budget adjustment in the amount of \$10,400 within the 2013 Bay County Golf Course budget for repair of 28 golf carts by the Buildings and Grounds Department is approved; Be It Further
RESOLVED	That County Administration is directed to proceed with an RFP for golf carts for the 2014 golf season in accordance with the County's Purchasing Policy.
