BY: PERSONNEL/HUMAN SERVICES COMMITTEE (5/21/13)  
 WHEREAS, With the retirement of Robert Redmond, Board Financial Analyst, it is the desire of the Bay County Board of Commissioners, at this time, to reduce the Financial Analyst's position from full time (2,080 hours per year) to part time (up to 1,000 hours per year) and to realize a savings to the general fund; and  
 WHEREAS, The annualized savings for a full calendar year is approximately \$48,096; and  
 WHEREAS, Robert Redmond will continue to hold this position; Therefore, Be It  
 RESOLVED By the Bay County Board of Commissioners that the hours of the position of Board's Financial Analyst are reduced from full time to part time (up to 1,000 hours for the remainder of 2013, effective June 15, 2013, and up to 1,000 hours for each subsequent year); Be It Further  
 RESOLVED That the hourly rate for the part time Financial Analyst position shall be \$33.68 per hour with no fringe benefits other than required by law; Be It Finally  
 RESOLVED That the Board's Financial Analyst position will continue to be non-union, at-will under the Bay County Personnel Policy.
