At a regular meeting of the Board of Commissioners of the County of Bay, Michigan (the "County"), held on the 17th day of December, 2024.

WHEREAS, this Board of Commissioners has determined that it is necessary to acquire, construct and finance improvements to the Bay County Water Supply System (the "System"), consisting without limitation of the acquisition and construction of water storage tanks at the Bay Area Water Treatment Plant, as well as all work necessary and incidental to these improvements, including without limitation the restoration of property, streets, rights-of-way, and easements affected by the improvements (collectively, the "Project"); and

WHEREAS, this Board of Commissioners has determined that the Project can be financed most economically and efficiently by the County through the exercise of the powers conferred by Act 34, Public Acts of Michigan, 2001, as amended ("Act 34"); and

WHEREAS the County is authorized pursuant to the terms of Act 34 to issue its bonds to finance the cost of the acquisition and construction of the Project, which bonds will be secured by revenues of the System and the County's full faith and credit pledge; and

WHEREAS it is anticipated that the County will advance all or a portion of the costs of the Project prior to the issuance of the bonds, such advance to be repaid from proceeds of the bonds upon the issuance thereof; and

WHEREAS Section 1.150-2 of the Treasury Regulations on Income Tax (the "Reimbursement Regulations") specifies conditions under which a reimbursement allocation may be treated as an expenditure of bond proceeds, and the County intends by this resolution to qualify amounts advanced by the County to the Project for reimbursement from proceeds of the bonds in accordance with the requirements of the Reimbursement Regulations; and

WHEREAS, a notice of intent to issue the Bonds must be published in order to comply with the requirements of Section 517(2) of Act 34.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Bay, Michigan, as follows:

- 1. The Project shall consist of the capital improvements described in the preamble hereto.
- 2. The County hereby declares its official intent to issue its limited tax general obligation bonds in one or more series in the aggregate principal amount of not to exceed \$15,280,000 to finance all or part of the cost of the Project. The County hereby declares that it reasonably expects to seek reimbursement for its advances to the Project as anticipated by this resolution.
- 3. The Clerk is hereby instructed to publish the notice attached hereto as Exhibit A once in a newspaper of general circulation in the County, which notice shall not be less than ½ page in size in such newspaper, with such changes as the Clerk shall deem necessary or appropriate, upon the advice of bond counsel.
- 4. The Bonds shall be authorized by proper proceedings of the County subsequent to this resolution.
- 5. All prior resolutions and parts of resolutions insofar as they may be in conflict herewith are hereby rescinded.







## **CITIZENS INPUT**

## PETITIONS AND COMMUNICATIONS

MR. REAUME:

MY NAME IS JIM REAUME, PRESIDENT AND CEO OF BAY FUTURE. OUR SUMMER HAS BEEN FULL OF CONCERTS, FESTIVALS, AND PROFESSIONAL FISHING TOURNAMENTS THAT ARE ECONOMIC DRIVERS BRINGING MILLIONS OF DOLLARS INTO OUR COMMUNITY. MY GOAL IS FOR YOU TO HAVE A BETTER UNDERSTANDING OF WHAT BAY FUTURE IS AND THE SERVICE WE BRING TO BAY COUNTY.

BAY FUTURE IS COMMITTED TO PROVIDING TOP-NOTCH SERVICE. THIS IS EVIDENT BY ITS EMPLOYEES AND THEIR LOVE FOR OUR COMMUNITY. MICHELLE JUDD IS BAY COUNTY'S SMALL BUSINESS DEVELOPMENT CENTER BUSINESS CONSULTANT. AS I MENTIONED EARLIER, MY NAME IS JIM REAUME. I ADVOCATE FOR BAY COUNTY AND ITS CITIZENS INSIDE AND OUTSIDE OF OUR COMMUNITY. OUR NEWEST TEAM MEMBER IS JOSE RIOS, III. HE IS BAY FUTURE'S ECONOMIC DEVELOPMENT MANAGER. JOSE BRINGS A FRESH PERSPECTIVE TO BAY FUTURE AND IS LOOKING FORWARD TO MAKING POSITIVE CHANGES IN THE COMMUNITY.

ECONOMIC DEVELOPMENT CAN BE DIFFICULT TO DEFINE, ESPECIALLY FOR THOSE OUTSIDE OF THE PROFESSION. OUR MISSION IS TO INCREASE THE TAX BASE, WHICH IN TURN INCREASES SERVICES MUNICIPALITIES CAN PROVIDE TO THEIR CITIZENS. WE SUPPORT JOB RETENTION, CAREER ADVANCEMENT, AND CONNECTING WORKFORCE AND EMPLOYERS

IN THE LABOR MARKET. OUR MISSION IS ACCOMPLISHED BY FOLLOWING FIVE TACTICS OF OUR STRATEGIC PLAN. THE FIRST TACTIC IS THE DEVELOPMENT OF EXISTING BUSINESSES AND ENTREPRENEUR DEVELOPMENT. 80 TO 90 PERCENT OF ALL NEW JOBS COME FROM EXISTING BUSINESSES. BAY FUTURE MEETS WITH ONE HUNDRED TARGETED BUSINESSES PER YEAR TO PROVIDE RESOURCES AND PROGRAMMING AIMED AT BUSINESS HEALTH AND STIMULATING GROWTH. IN MAY OF 2024 WE HELD THE FIRST GREAT LAKES BAY SUPPLIER SUMMIT AT THE DOUBLE TREE, WHICH FEATURED PRODUCT BUYERS AND MUNICIPALITIES. THE BUYERS INTERACTED WITH 125 SUPPLIERS WHO HAD GOODS OR SERVICES TO SELL. THESE EVENTS ARE IMPORTANT BECAUSE IT CAN BE A MYSTERY FOR SMALL BUSINESSES TO LEARN HOW TO DO BUSINESS WITH A LOCAL MUNICIPALITY OR A CORPORATE ENTITY. THESE SUPPLIERS WERE ABLE TO MAKE CONNECTIONS WITH THE PROCUREMENT TEAMS OF THESE ORGANIZATIONS AND DIVERSIFY THEIR CUSTOMER BASE. THIS IS ACCOMPLISHED THROUGH TEAMWORK.

SINCE 2020 BAY FUTURE HAS FACILITATED MORE THAN \$1 BILLION IN CAPITAL INVESTMENT IN BAY COUNTY, WHICH HAS RESULTED IN MORE THAN 900 ADDED JOBS. MANY OF THESE JOBS ARE RESPONSIBLE FOR INCREASING BAY COUNTY'S AVERAGE HOURLY WAGE FROM \$22.42 IN 2020 TO \$25.28 IN 2024.

BAY FUTURE ALSO RESPONDS TO RFP AND RFQ SUBMISSIONS FOR SITE SELECTION. THESE REQUESTS OFTEN LEAD TO SITE VISITS AND PRESENTATIONS TO SITE SELECTORS TO HELP THEM UNDERSTAND WHAT BAY COUNTY IS ABOUT. ECONOMIC DEVELOPMENT IS A COMPETITIVE SPORT. MANY OF YOU MAY BE THINKING, WHY DON'T WE JUST PITCH FOR A CERTAIN COMPANY OR CORPORATION TO MOVE HERE TO BAY COUNTY? IF IT WERE THAT EASY, MY JOB WOULD NOT BE NECESSARY. A RECENT SUCCESS STORY ABOUT A COMPANY FINDING A NEW HOME HERE IN BAY COUNTY IS PROGRESSIVE MECHANICAL. PROGRESSIVE MECHANICAL IS HEADQUARTERED DOWN IN CLAWSON. THEY WERE LOOKING TO ADD TO THEIR CAPABILITIES AND THEY NEEDED A BUILDING. THERE JUST HAPPENED TO BE A BUILDING ABOUT THE SIZE THEY WERE LOOKING FOR IN MONITOR TOWNSHIP. THEY ARE CURRENTLY

REHABILITATING A PREVIOUSLY VACANT BUILDING, ADDING \$2.5 MILLION IN INVESTMENT FOR IMPROVEMENTS. THIS VACANT BUILDING HAS GENERATED TAXES FOR THE TOWNSHIP AND HAS ADDED 25 HIGHLY SKILLED AND WELL-PAID WORKERS PLYING THEIR TRADE IN OUR COUNTY.

NOW THAT WE'VE ADDED THESE 900 NEW JOBS, OUR NEXT STEP IS TO HELP COMPANIES GET THE EMPLOYEES TRAINED. THE GOING PRO TALENT FUND IS A COMPETITIVE GRANT LED LOCALLY BY OUR FRIENDS AT GREAT LAKES BAY MICHIGAN WORKS. GOING PRO CAN HELP COMPANIES WITH THE COST OF QUALIFIED TRAINING PROGRAMS. SINCE 2020 BAY COUNTY COMPANIES HAVE LEVERAGED MORE THAN \$2.1 MILLION OF THESE TRAINING FUNDS. THESE DOLLARS ARE GOING TO BE SPENT SOMEWHERE IN MICHIGAN, SO WHY NOT BAY COUNTY?

BAY FUTURE RELIES HEAVILY ON PARTNERS THAT OFFER HIGHLY SIGNIFICANT TRAINING PROGRAMS. DELTA COLLEGE IS OUR LOCAL PARTNER OFFERING MICHIGAN RECONNECT AND THE MICHIGAN NEW JOBS TRAINING PROGRAM. MICHIGAN RECONNECT PROVIDES TUITION-FREE ACCESS TO COMMUNITY COLLEGE TO MICHIGANDERS 21 OR OLDER WITHOUT COLLEGE DEGREES TO PURSUE ELIGIBLE ASSOCIATE DEGREES OR OCCUPATIONAL CERTIFICATES. THE MICHIGAN NEW JOBS TRAINING PROGRAM IS AN ECONOMIC DEVELOPMENT TOOL FOR NEW AND EXPANDING BUSINESSES, PROVIDING THE ABILITY TO TRAIN THEIR WORKFORCE AT VIRTUALLY NO COST WHEN THEY IMPLEMENT A TRAINING AGREEMENT WITH DELTA COLLEGE. THE PAYROLL TAX THAT IS NORMALLY PAID TO THE STATE OF MICHIGAN FOR THESE QUALIFIED ROLES IS INSTEAD DIVERTED TO PAY FOR EMPLOYEE TRAINING. THIS RESULTS IN THOUSANDS OF DOLLARS OF FREE TRAINING FOR NEW EMPLOYEES IN **OUALIFIED POSITIONS.** 

BUSINESSES AND EMPLOYERS WHO ARE LOOKING TO RELOCATE OR EXPAND OFTEN LOOK AT FACILITIES OR SITES WITH DEVELOPED INFRASTRUCTURE THAT ADDRESS THEIR NEEDS. BAY FUTURE IS TASKED WITH KEEPING A LIST OF THESE AVAILABLE SITES AND MAKING SURE THEY'RE READY TO SUBMIT FOR POTENTIAL PROJECTS. A NEW CATALOG OF THESE SITES WILL BE UNVEILED LATER IN 2024, AIMED AT INCREASING OUR COMPETITIVE EDGE AND MAKING BAY COUNTY MORE

ATTRACTIVE. ONE WAY THAT BAY FUTURE HAS WORKED TO INCREASE THE READINESS OF SITES IS BY ACQUIRING GRANT DOLLARS TO BUILD OUT INFRASTRUCTURE TO DEVELOP PLANS ON SITES. CURRENTLY BAY FUTURE IS WORKING WITH MONITOR TOWNSHIP, BAY COUNTY DEPARTMENT OF WATER AND SEWER, BAY COUNTY ROAD COMMISSION AND THE SPICER GROUP TO UTILIZE A \$4.1 MILLION GRANT TO ADD MUCH-NEEDED SANITARY SEWER INFRASTRUCTURE IMPROVEMENTS TO THE THREE MILE AND WILDER ROAD AREA. THESE IMPROVEMENTS WILL NOT ONLY HELP EXISTING BUSINESSES BUT WILL ALLOW US TO ATTRACT NEW BUSINESS TO THOSE PARCELS.

MERSEN IS A COMPANY LOCATED IN BAY CITY THAT HAS SEEN DRAMATIC GROWTH AND INCREASING DEMAND FOR ITS GRAPHITE PRODUCTS THAT ARE USED TO MANUFACTURE SILICONE CHIPS AND SEMICONDUCTORS. THEIR CUSTOMERS WANTED MORE OUTPUT SO THEY NEEDED TO EXPAND. MERSEN IS HEADQUARTERED IN FRANCE AND HAS HAD COMPETITIVE OFFERS TO MOVE TO OTHER STATES. WITH HARD WORK FROM THE MICHIGAN ECONOMIC DEVELOPMENT CORPORATION, CITY OF BAY CITY, AND BAY CITY ELECTRIC LIGHT AND POWER, A PACKAGE WAS PUT TOGETHER TO ATTRACT MORE THAN \$75 MILLION IN INVESTMENT AND ADD 90 HIGH-PAYING JOBS. WE'RE LOOKING FORWARD TO A RIBBON CUTTING TO BE SCHEDULED IN THE SPRING OF 2025.

VANTAGE PLASTICS IS A SUCCESSFUL COMPANY LOCATED IN ARENAC COUNTY AND NEEDED TO EXPAND. COMPANIES LIKE VANTAGE GET SUBSTANTIAL OFFERS FROM OTHER STATES WITH INCENTIVES LIKE NO INCOME TAX, FREE LAND, AND LOWER ENERGY RATES. THOSE STATES LACK A HIGHLY SKILLED WORKFORCE, AND THAT HELPS MICHIGAN AND BAY COUNTY WIN DEALS LIKE THIS. VANTAGE PLASTICS WAS GUIDED TO BAY FUTURE TO HELP AND SEE WHAT WAS AVAILABLE. THEY FOUND THE FORMER DOW PLASTIC PIPE BUILDING BUT IT NEEDED A TON OF WORK. WITH TEAMWORK FROM THE MEDC, BANGOR TOWNSHIP, AND CONSUMERS ENERGY, THIS PROJECT CAME TOGETHER. VANTAGE IS INVESTING MORE THAN \$31 MILLION AND ADDING 93 JOBS. THIS PROJECT WILL FEATURE THE REHABILITATION OF A SECTION OF WILDER ROAD IN 2025 WITH HELP FROM MDOT, CITY OF BAY CITY, AND BAY COUNTY ROAD COMMISSION.

MICHIGAN SUGAR HAS INVESTED MILLIONS INTO IMPROVING THEIR FACILITY AND THEIR PROCESSES. THIS PROJECT WILL LEAD TO MORE SUGAR ON STORE SHELVES AND MORE MONEY FOR THE GROWER OWNERS, BUT IT'S ABOUT MORE THAN THAT. THIS PROJECT IS A CASE STUDY IN SUSTAINABILITY. THE ADDITION OF THE DESUGARIZATION FACILITY WILL ALLOW MICHIGAN SUGAR TO INCREASE ITS OUTPUT BY 80 MILLION POUNDS OF SUGAR EACH YEAR. AS A COMMUNITY WE CAN ALL TAKE PRIDE THAT COMPANIES LIKE MICHIGAN SUGAR ARE INVESTING TO SUSTAIN OUR ENVIRONMENT AND COMMUNITY. THIS PROJECT WAS BROUGHT HOME WITH THE HELP OF MEDC AND MONITOR TOWNSHIP, AND A PORTION OF EUCLID WAS REDONE WITH HELP FROM MDOT, CITY OF BAY CITY, AND BAY COUNTY ROAD COMMISSION.

EVERY SINGLE BAY COUNTY BUSINESS IS CURRENTLY PAYING FOR MICHELLE TO BE A CONSULTANT ON THEIR STAFF. SHE HAS MET WITH MORE THAN 180 CURRENT AND POTENTIAL BUSINESSES SO FAR. MICHELLE AND THE SBDC OFFER A MULTITUDE OF FREE AND CONFIDENTIAL SERVICES. A SERVICE SBDC OFFERS AT NO COST IS SECONDARY MARKET RESEARCH THAT PROVIDES BUSINESSES WITH A BETTER UNDERSTANDING OF HOW TO REACH THEIR TARGET AUDIENCE.

MICHELLE'S MEETINGS ARE ALWAYS 100% CONFIDENTIAL. ONE WAY TO SUPPORT THE SBDC AND THE BUSINESSES WHO ENGAGE IS BY ATTENDING THE PITCH BY THE BAY COMPETITION ON NOVEMBER  $13^{\text{TH}}$ , AT JOHN GLENN HIGH SCHOOL.

JIM, YOU HAVE INSPIRED CONFIDENCE FROM ALL WHO HAVE WORKED WITH YOU AND I WANT TO COMPLIMENT YOU ON THE LEADERSHIP YOU'VE SHOWN. THE LIST OF INVESTMENTS THAT WE MADE HAS BEEN NOTHING SHORT OF MIRACULOUS SO IF ANYONE HAS QUESTIONS ABOUT THE EXECUTIVE BUDGET THIS YEAR, I DID TWEAK IT AND INCREASED FROM \$75,000 TO \$100,000 OUR ANNUAL APPROPRIATION TO CONTINUE TO BE A PREMIER SPONSER OF BAY FUTURE. THIS REPORT SHOWS THE MILLAGE RATES, THE CURRENT TAXABLE VALUE, AND AN ESTIMATION OF WHAT THOSE MILLAGES WILL GENERATE IN TAX DOLLARS. THE ESTIMATE TENDS TO BE HIGH BECAUSE IT DOESN'T TAKE INTO ACCOUNT THE DIFFERENT EXEMPTIONS AND ABATEMENTS SET THROUGHOUT THE COUNTY.

THE APPORTIONMENT REPORT IS CREATED THROUGH THE MILLAGE REDUCTION FRACTION COMPUTATION (L-4028), THE MILLAGE REDUCTION FRACTION CALCULATION WORKSHEET (L-4034), AND THE TAX RATE REQUEST (L-4029).

THE MILLAGE REDUCTION FRACTION IS WHAT THESE REPORTS REVOLVE AROUND. IT COMES INTO PLAY WHEN A TAXING AUTHORITY'S TAXABLE VALUE FROM LAST YEAR TO THIS YEAR GROWS MORE THAN THE CURRENT RATE OF INFLATION. THE RATE OF INFLATION WE USED LAST YEAR WAS 5.1%. IF THE TOWNSHIP'S TAXABLE VALUE INCREASED MORE THAN 5.1% IGNORING THE LOSSES AND ADDITIONS, THEIR MILLAGE WOULD BE REDUCED. THIS IS TO REDUCE THE TAX BURDEN ON TAXPAYERS. A MILLAGE REDUCTION FRACTION CANNOT EXCEED ONE.

AND DEVELOPMENT AUTHORITIES, WE SEND THIS REPORT TO SURROUNDING COUNTIES BECAUSE THE DISTRICTS DON'T FOLLOW COUNTY LINES. WE RECEIVE THEIR 4028 IN TURN AND COMPILE THOSE TOTALS TO CREATE A MILLAGE REDUCTION FRACTION FOR ALL THE SCHOOL DISTRICTS. THAT REPORT FEEDS INTO THE MILLAGE REDUCTION FRACTION CALCULATIONS WORKSHEET AND IS SENT TO THE TOWNSHIPS AND CITIES. IT INCLUDES THE TAXABLE VALUE, INFLATION RATE, A BREAKDOWN OF THE MILLAGE REDUCTION FRACTION, AND THE MILLAGE REDUCTION FRACTION THEY ARE REQUIRED TO USE FOR THIS YEAR. # COUNTY EXECUTIVE, JIM BARCIA

MR. BARCIA:

WESTON PRINCE, WHO IS OUR BAY COUNTY TREASURER AND CHAIR OF THE BAY COUNTY LANDBANK, TOOK A LEADING ROLE IN SECURING A \$2.1 MILLION GRANT FROM THE MICHIGAN STATE LANDBANK AUTHORITY. IT WILL BE USED TO DEMOLISH THE FORMER COUNTY RESTAURANT, COUNTY FLEA MARKET, THE PAVILION, AND THE OLD YMCA. ALL OF THE PROPERTIES WERE CONTAMINATED WITH ASBESTOS, MERCURY, AND OTHER CONTAMINANTS. WITH BILL PHILLIPS AND DANA MUSCOTT FROM BAY CITY LEADING THE WAY, 104 MULTI-FAMILY HOUSING UNITS WILL REPLACE THOSE STRUCTURES. THIS WILL HELP ALLEVIATE PRESSURE ON HOUSING AND HOUSING COSTS IN BAY COUNTY. SENIOR CITIZENS, THE PHYSICALLY IMPAIRED, AND YOUNG PEOPLE STARTING OUT WHO ARE LOWER INCOME WILL QUALIFY FOR RESIDENCY AT THAT HOUSING COMPLEX. THE 900 FULL-TIME JOBS JIM EXPLAINED ARE CAPABLE OF SUSTAINING A FAMILY AND WILL EXPERIENCE GROWTH, WE HAVE TURNED THE CORNER ON OUR POPULATION LOSS AND HAVE GROWN RESIDENTS SINCE 2023, WHICH IS THE FIRST TIME IN A GENERATION. I'D LIKE TO HAVE OUR BAY COUNTY TREASURER GIVE THE BOARD AN UPDATE ON WHAT WE COVERED. DANA MUSCOTT, WESTON, AND I ANSWERED QUESTIONS FROM THE MEDIA. THANK YOU, WESTON, FOR SETTING THAT UP BECAUSE WE HAVE GREAT COVERAGE.

MR. PRINCE:

JIM COVERED A BIG CHUNK OF IT BUT I'D LIKE TO DISPEL SOME DISINFORMATION THAT'S GONE OUT, MANY PEOPLE SEEM TO THINK THE \$40 MILLION IS COMING FROM EITHER THE COUNTY OR THE CITY WHICH NEITHER OF US HAS TO GIVE. THE

DEVELOPMENT FUNDS WILL COME FROM LOW-INCOME HOUSING TAX CREDITS APPLIED FOR THROUGH MSHDA. THE HOUSING COMMISSION WILL HANDLE THAT AND DO THE BUILDING OF THE PROJECT. OUR PART WILL BE REMEDIATING AND DEMOING THE PROPERTY TO PREP FOR THE BUILD ON IT. THE CITY DID A STUDY THAT FOUND A SHORTAGE OF 900 AFFORDABLE HOUSING RENTAL UNITS LOCATED WITHIN THE CITY. THE 104 TO 112 AFFORDABLE HOUSING UNITS GOING INTO THAT AREA WILL ONLY MAKE A SMALL DENT BUT WILL PROVIDE A LOT OF AMENITIES IN A SHORT SPACE FOR THOSE INDIVIDUALS TO THRIVE IN. I'M HAPPY TO ANSWER ANY QUESTIONS ON THIS PROJECT.

## COMMISSIONER COMMENTS

COMM. BEGICK:

I HAVE A REPORT OF THE FINANCE COMMITTEE. MR. BANASZAK, MS. MAILLETTE, AND I WERE PRESENT. IT WAS ON OCTOBER 3, WITH SHAWNA WALRAVEN, KIM PRIESSNITZ, AND LINDSEY TO DISCUSS THE 2025 BUDGET PROCESS. WE HELD A MEETING TODAY TO RATIFY WHAT WE HAD ALREADY DISCUSSED. TENTATIVE FINAL APPROVAL BY THE BOARD OF COMMISSIONERS WILL BE HELD ON NOVEMBER 19. THERE WILL BE A PUBLIC HEARING SCHEDULED FOR NOVEMBER 12, 2024. THE COMMITTEE REVIEWED THE LIST OF REQUESTED ACTIONS FOR THE 2025 BUDGET AT THE BOARD OF COMMISSIONERS LEVEL WITH NO CHANGES. THERE WEREN'T MANY NEW SERVICE ENHANCEMENT REQUESTS. THE COUNTY EXECUTIVE HAD A CHAT WITH SOME OF THE DEPARTMENT HEADS AND ASKED THEM TO KEEP IT LOW.

MR. BARCIA:

IT'S GOING TO BE DIFFICULT TO REPLACE SHAWNA AND IT WILL BE AN EXTENSIVE PROCESS. HOWEVER, A LOT OF OUR PEOPLE IN FINANCE AND THE EXECUTIVE BRANCH HAVE STOOD UP TO THE DEMANDS WE HAVE AND I KNOW WE'LL GET THROUGH.

COMM. BEGICK:

WE TALKED ABOUT UPDATING FRINGE RATES, HEALTH INSURANCE RATES, GRANTS, AND PERSONNEL CHANGES. THE NEW CONTRACT WILL BE COMING UP FOR DISCUSSION NEXT YEAR SO TIFFANY WILL BE BUSY. IT WAS SUPPORTED BY COMM. RADTKE AND PASSED BY ROLL CALL VOTE: 5 YEAS: (MAILLETTE, HEREK, RADTKE, JOHNSON, BEGICK); 2 NAYS: (NIEMIEC, BANASZAK); 0 EXCUSED.

COMM. BANASZAK: IT SEEMED LIKE TWO YEARS AGO THIS WAS ALSO ON THE AGENDA WHEN THE OUTGOING COMMISSIONERS WANTED TO ELIMINATE THE HEALTH CARE AND THE PAY FOR THE NEWCOMING COMMISSIONERS. CAN YOU EXPLAIN WHY, TOM, YOU ARE DOING THIS AGAIN?

COMM. HEREK:

IF YOU GO TO SAGINAW OR MIDLAND OR JUST ABOUT ANY PLACE ELSE THE COMMISSION DOES NOT GET HEALTH CARE. THE COUNTY PORTION FOR HEALTHCARE FOR A COMMISSIONER NEXT YEAR WILL BE \$29,000. ADD THAT TO YOUR SALARY AND NOW WE'RE PUTTING UP THE COMMISSION AT \$43,000 WHICH I THINK IS A LITTLE EXTREME FOR WHAT WE DO HERE. WE WORK HARD, BUT WE HAVE A LOT OF COUNTY EMPLOYEES MAKING \$15/HR THAT DON'T REAP THAT BENEFIT. WHEN I CAME HERE I DIDN'T CARE ABOUT THE HEALTH CARE, I WORKED HARD AND IT WORKED OUT FOR ME AND IT'S THE SAME WITH A LOT OF THE OTHER COMMISSIONERS. I DON'T KNOW HOW PEOPLE CAN LIVE WITH THIS NUMBER. A SALARY COMES WITH THE JOB AND OTHER STIPENDS AND WE ELIMINATED A LOT OF THOSE A COUPLE OF YEARS AGO. I JUST DON'T THINK IT'S RIGHT, THAT IS MY REASON.

COMM. BANASZAK: I'D LIKE TO REBUT WHAT YOU SAID ABOUT \$29,000 FOR A PACKAGE. EXCUSE ME BUT TOM, YOU ARE WRONG. I GET HEALTHCARE AND IT'S \$18- \$19,000 FOR MY WIFE AND ME. \$29,000 IS A PACKAGE IF YOU SIT HERE AND WORK AS A FULL-TIME EMPLOYEE. ANOTHER THING, EVERY ONE OF US HAS THE OPPORTUNITY TO GET INSURANCE. COLLEEN AND I ARE THE ONLY ONES WHO GET IT. EVERYBODY ELSE HAS GOT IT THROUGH THEIR WORK OR RETIREMENT. BUT TWO YEARS AGO, YOU VOTED FOR US NEWCOMING COMMISSIONERS TO ELIMINATE THAT. REMEMBER THAT? WHY DID HE CHANGE TWO YEARS AGO? TELL ME WHY YOU WANTED TO GET RID OF IT LAST YEAR, AND NOW YOU WANT TO GET RID OF IT AGAIN.

COMM. BEGICK:

I WANT TO REFER TO OUR LEGAL DEPARTMENT SINCE SEVERAL YEARS AGO WE WERE TOLD THAT WE ARE FULL-TIME EMPLOYEES AND THEY HAVE TO OFFER HEALTHCARE SO I DON'T KNOW IF THAT POSITION HAS CHANGED.

MS. JOHNSON:

UNDER THE ACA, IF THEY ARE FULL-TIME EMPLOYEES, WE ARE REQUIRED TO PROVIDE COMMISSIONERS WITH HEALTH INSURANCE. WE DISCUSSED THIS A NUMBER OF YEARS AGO, WHETHER OR NOT THE ACA REQUIRED US TO PROVIDE THAT INSURANCE. WE INDICATED TO THE COMMISSIONERS THAT IF IN FACT YOU WERE WILLING TO SIGN AN AFFIDAVIT THAT INDICATED THAT YOU WERE NOT WORKING MORE THAN 29 HOURS PER WEEK, YOU WOULD AUTOMATICALLY BE EXCLUDED FROM THAT REQUIREMENT THAT WE PROVIDE HEALTHCARE AND THE COMMISSIONERS WERE UNWILLING TO DO SO. WE ALSO INDICATED THAT THE COMMISSIONERS COULD TURN IN TIME SHEETS TO INDICATE THAT THEY WERE NOT WORKING MORE THAN 29 HOURS PER WEEK. THE COMMISSIONERS, AT THAT POINT IN TIME WERE NOT WILLING TO DO SO. I DON'T BELIEVE THE \$1,800 STIPEND FOR NOT TAKING THE HEALTH INSURANCE WAS ADDRESSED AT EITHER OF THOSE VOTES, THAT'S A NEW ISSUE WE HAVE NOT DISCUSSED BEFORE. THE ACA IS NOT IMPLICATED IN THAT. I WOULD ALSO NOTE THAT THE COUNTY IS REQUIRED TO PROVIDE HEALTH INSURANCE UNDER THE ACA TO ALL FULL-TIME EMPLOYEES WITH THE EXCEPTION OF 5%. WE CAN BE OFF BY 5% AND IF IT WERE NOT PROVIDED TO THE COMMISSIONERS WE WOULD FALL WITHIN THAT 5% AND WOULD NOT BE PENALIZED FOR IT. SO IT IS A CHOICE THAT THE COMMISSIONERS CAN MAKE AS TO WHETHER OR NOT THEY WANT TO RETAIN THAT BENEFIT.

COMM. JOHNSON: I WAS HERE TWO YEARS AGO AND THIS TOPIC DID NOT COME UP. WHAT DID COME UP WAS REMOVING THE STIPEND THAT GOES WITH CERTAIN MEETINGS YOU CAN ATTEND. I KNOW IT DIDN'T COME UP TWO YEARS AGO BECAUSE IF IT HAD I WOULD HAVE VOTED TO REVOKE THAT. I WAS DOING RESEARCH BEFORE I RAN IN 2020, AND I DISCOVERED THAT IN 2012 THE COMMISSION VOTED TO GET HEALTH CARE FOR WHAT IS ESSENTIALLY A PART-TIME POSITION. OUR PART-TIME EMPLOYEES DON'T GET THAT BENEFIT. THERE ARE PEOPLE IN MY DISTRICT WHO WERE COMPLETELY SURPRISED THAT THIS BENEFIT WAS ALLOTTED TO THE COMMISSIONERS AND THEY WEREN'T HAPPY WITH THE SIZE OF THE PACKAGE. IN 2021 IT WAS ALMOST \$18,000. IF YOU ADD THAT TO THE COST OF THE \$12,000 BASE PAY, YOU'RE LOOKING AT A SUBSTANTIAL AMOUNT. WITH THE INCREASE IN PAY DEPENDING ON THE CONTRACTS AS THINGS GO UP, AND THE CHAIR'S AMOUNT THAT WOULD BE ALLOTTED WHICH IS 20% ON TOP OF THAT, YOU'RE LOOKING AT A PAY AND BENEFITS PACKAGE THAT COULD CREEP INTO THE \$40,000'S. THAT MONEY IS COMING OUT OF THE POCKETS OF PEOPLE WHO CAN'T AFFORD THAT TYPE OF CARE. IF IT HAD COME UP TWO YEARS AGO, I WOULD HAVE VOTED TO GET RID OF IT AND THE OPPORTUNITY IS HERE.

MS. JOHNSON:

I WANT TO MAKE ONE CLARIFICATION. I KNOW THAT THIS IS COMING UP AS PART OF THE BUDGET DISCUSSION BECAUSE THIS IS INCLUDED IN THE BUDGET. I WANT TO MAKE CLEAR THAT HEALTHCARE IS A FRINGE BENEFIT THAT IS NOT INCLUDED IN A COMPENSATION PACKAGE, SO THIS IS NOT THE BOARD VOTING ON THE NEXT TERM'S COMPENSATION PACKAGE WHICH HAS TO BE DONE BEFORE THE NEW BOARD TAKES THEIR SEATS. HEALTH CARE IS A FRINGE BENEFIT, NOT A COMPENSATION ISSUE THAT YOU'RE VOTING ON. I WANT TO MAKE SURE THAT DISTINCTION IS CLEAR IF THERE WAS ANY CONFUSION.

COMM. BEGICK:

WHAT WE DECIDE HERE DOESN'T APPLY TO THE NEXT COMMISSION THEN YOU'RE SAYING?

MS. JOHNSON:

WHAT YOU DECIDE HERE WOULD APPLY TO THE NEXT COMMISSION UNTIL IT WAS VOTED DIFFERENTLY. WHAT I'M SAYING IS THIS IS NOT A COMPENSATION ISSUE AND CANNOT BE CHANGED THROUGHOUT THE COURSE OF THE NEXT COMMISSION'S TENURE BECAUSE IT IS NOT COMPENSATION. THE LAW SAYS THAT IF YOU'RE GOING TO CHANGE YOUR COMPENSATION AS COMMISSIONERS THE OUTGOING BOARD HAS TO VOTE ON WHAT THE INCOMING BOARD GETS AND IT CAN'T CHANGE DURING THAT FOUR YEARS. HEALTHCARE IS NOT COMPENSATION UNDER THE STATUTE, IT IS A FRINGE BENEFIT.

COMM. BEGICK:

COULD YOU RESTATE THE AMENDMENT AGAIN?

IT WOULD BE THE ELIMINATION OF HEALTH CARE AND THE COMM. HEREK:

STIPEND FOR NOT TAKING THE HEALTH CARE OUT OF THE

BUDGET.

COMM. BANASZAK: DID HE SAY THAT RIGHT? THAT'S A FRINGE BENEFIT HE'S TAKING

OUT OF THE PACKAGE FOR NEXT YEAR.

IT IS A BUDGETED DOLLAR AMOUNT FOR THAT POTENTIAL FRINGE MS. JOHNSON:

BENEFIT FOR ALL OF THE COMMISSIONERS THAT COME IN. WHETHER IT'S UTILIZED OR NOT, IT'S STILL A BUDGETED NUMBER. HE'S MOVING TO REMOVE THAT FROM THE BUDGET SO IF THAT WERE TO BE PROVIDED TO THE COMMISSIONERS NEXT YEAR YOU WOULD HAVE TO VOTE TO DO THAT. THERE WOULD

HAVE TO BE A BUDGET ADJUSTMENT.

MR. BARCIA:

WE HAD OUR INITIAL MEETING ON THE COMMUNITY CENTER POOL. WE TALKED ABOUT WHETHER BONDS WILL BE SOLD, FINANCING, AND WHAT KIND OF TIME FRAME WE'RE LOOKING AT. IT WAS A CLOSE VOTE BUT THE PEOPLE OF BAY COUNTY DID VOTE TO APPROVE THE .35 MILLAGE. LAST WE HEARD THEY ARE ABOUT TWO YEARS BEHIND IN TERMS OF WAIT TIME FOR CONSTRUCTION. NONETHELESS, WE'RE GOING TO PROCEED AND TRY TO MAKE THOSE DECISIONS AS BEST AS WE CAN SO THE POOL IS OPEN AS SOON AS POSSIBLE FOR THE RESIDENTS OF BAY COUNTY.

# COUNTY CLERK, KATHLEEN ZANOTTI

MS. ZANOTTI:

WE CERTIFIED THE NOVEMBER ELECTION THIS PAST FRIDAY. I'VE HAD SEVERAL TOWNSHIP AND CITY CLERKS TELL ME THIS WAS THE SMOOTHEST ELECTION THAT THEY'VE HAD IN THEIR CAREERS CONSIDERING THE HIGH TURNOUT. FOR EARLY VOTING WE HAD ABOUT 700 VOTERS OVER 9 DAYS IN FEBRUARY, ABOUT 560 IN AUGUST, AND OVER 9,000 IN NOVEMBER. MY WORKERS DID A FANTASTIC JOB. REBECCA GRZEGORCZYK DID A WONDERFUL JOB. THE WAIT TIME WAS ABOUT 20 MINUTES, I DON'T THINK IT CAN BE MUCH BETTER. I ANTICIPATE THAT NOW VOTERS ARE AWARE OF EARLY VOTING THEY'LL CONTINUE TO SHOW UP. IN 2026 WHEN WE HAVE EARLY VOTING FOR THE GOVERNOR'S RACE, I EXPECT WE'LL HAVE TO MAKE CHANGES TO ACCOMMODATE MORE VOTERS.

COMM. BANASZAK: THE SHERIFF AIRBOAT THAT WE'VE BEEN WAITING FOR THE PAST 16 MONTHS HAS ARRIVED. OUR FLEET IS NOW UP TO DATE AND WE'RE VERY HAPPY WITH THIS AIRBOAT.

MR. BARCIA:

WE'RE VERY GRATEFUL TO CONGRESSMAN KILDEE WHO SECURED UNDER THE COMMUNITY PROJECT FUNDING ALMOST \$2 MILLION TO PROVIDE FOR 2 OF THE NEW MARINE PATROL BOATS AND ESPECIALLY THE AIRBOAT. THE ESSEXVILLE COAST GUARD STATION, DUE TO STAFFING ISSUES, WILL NO LONGER BE ABLE TO ENGAGE IN SEARCH AND RESCUE. IT DOESN'T MEAN IT WON'T BE AVAILABLE TO THE SAGINAW BAY BUT WE HAVE TO RELY ON EITHER TRAVERSE CITY OR DETROIT TO SEND HELICOPTERS UP. WE'RE GRATEFUL TO THE BOARD FOR APPROVING THAT AND ESPECIALLY TO CONGRESSMAN KILDEE FOR SECURING THE FUNDING. ALSO, WE HAD A VERY SUCCESSFUL TURNOUT FOR THE SCENIC ACCESS POINT AT THE END OF LINWOOD ROAD WHICH WILL ALSO BE AN ACCESS POINT FOR LAUNCHING WATERCRAFT. THINGS ARE COMING ALONG ON THE BAY AND THESE NEW WATERCRAFTS WILL HELP US PROTECT THE PUBLIC FROM THOSE EMERGENCY SITUATIONS THAT WE KNOW WILL OCCUR EVENTUALLY.

WE HAD A VETERANS AFFAIRS COMMITTEE MEETING EARLIER AND WE'VE RECEIVED A GRANT AGAIN THIS YEAR THAT WE PUT IN JUST ABOUT EVERY YEAR FOR 7 YEARS NOW. IT HELPS PAY FOR THE STAFF OF THE VETERAN'S AFFAIRS DOWNSTAIRS SO WE CAN SERVICE THE VETERANS AND GET THEIR CLAIMS APPROVED
