County Treasurer's Public Official Bond Status

Background:

As required by MCL 48,40a, the County Treasurer Shall provide a bond in an amount of at least \$1,000,000 for the faithful and proper discharge of the duties of the County Treasurer's office. The cost of the individual bond shall be paid from the General Fund of the County.

A public official bond for \$1,000,000 with Michigan Municipal Management Authority covering myself for the benefit of the Bay County has been in place since June 15, 2022, the day I took office. I have verified with the Bay County Risk Management that this bond is currently in effect and is expected to remain in effect throughout 2025.

Financial Impact:

There is no additional cost to the County. The bond in place meets the legal requirements.

BY:	BAY COUNTY BOARD OF COMMISSIONERS (1/21/25)
WHEREAS,	On February 3, 1943, four United States Army chaplains aboard the USAT Dorchester heroically gave their lives in the process of saving others as their ship was torpedoed and sank; and
WHEREAS,	When the supply of life jackets ran out on their sinking ship, Lieutenant George Fox, a Methodist minister, Lieutenant Alexander Goode, a Jewish rabbi, Lieutenant Clark Poling, a Dutch Reformed minister, and Lieutenant John Washington, a Roman Catholic priest, selflessly gave up their life jackets to those who had none; and
WHEREAS,	According to witnesses who survived the attack, the four chaplains linked arms, sang hymns, and offered prayers as they went down with their ship; and
WHEREAS,	More than 600 members of our nation's military tragically passed away that day, including the four chaplains, making it known as the second-worst sea disaster of WWII; and
WHEREAS,	Congress attempted to confer the Medal of Honor on the Chaplains but was prevented by strict guidelines; and
WHEREAS,	Instead, Congress authorized a one-time posthumous Special Medal for Heroism given by former President Eisenhower in 1961 with the intention of having the same weight and importance as the Medal of Honor; Therefore, Be It
RESOLVED	That the Bay County Board of Commissioners encourages and supports the observance of Four Chaplains Day and is honored to hereby designate February 3, 2025, as FOUR CHAPLAINS DAY in Bay County.

MY NAME IS RYAN GOEBEL; I'M THE DIRECTOR AT THE BAY COUNTY DEPARTMENT OF WATER AND SEWER. WE'RE HERE TODAY BECAUSE WE'RE HOPING TO SECURE A BOND FOR WATER TANKS. THE PLANT THAT WAS CONSTRUCTED IN 2015 IS THE LARGEST MEMBRANE PLANT IN THE STATE OF MICHIGAN. IT WORKS VERY WELL BUT WE DON'T HAVE ENOUGH STORED WATER ON SITE IF WE HAVE A PROBLEM WITH OUR PLANT. WE'RE GOING TO RUN DRY IN AS SHORT AS SIX HOURS. OUR GOAL IS TO CONSTRUCT TWO NEW CONCRETE WATER TANKS THAT WILL GIVE US AT LEAST 24 HOURS. IF THERE ARE ANY PROBLEMS OUR STAFF WILL FIX THEM SO WE CAN STAY RUNNING. OUR FINANCIAL ADVISOR, ANDY CAMPBELL IS HERE TO ANSWER ANY QUESTIONS ABOUT THE BONDING PROCESS.

COMM. BANASZAK: COULD YOU EXPLAIN WHERE THE MONEY IS COMING FROM AND HOW IT'S GOING TO AFFECT THE RESIDENTS?
