Terms and Conditions

1. Passes are valid for admission to all public skating sessions NOT for stick & puck or drop in hockey.
2. No refunds are offered on any unused portion of the pass.
3. The passes are the property of BCCA and maybe revoked for misconduct or misuse.
4. Pass holders must visibly wear the pass at all times when on the ice surface.
5. Pass holders must adhere to all arena rules when using the facility.
6. BCCA may at anytime establish other conditions associated with the use of this pass

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY, PARENTAL CONSENT AND PHOTO RELEASE AGREEMENT

In consideration of being permitted to participate in any way in Bay County Civic Arena programs I, for myself, my personal representatives, assigns, heirs, and next of kin: 1. Acknowledge, agree, and represent that I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity. 2. I fully understand that: (a) the Activity undertaken involves risks and dangers of serious bodily injury, including permanent disability, paralysis and death; (b) these risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at the time and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity. 3. I hereby release, discharge, and covenant not to sue Bay County, its respective administrators, directors, agents, officers, volunteers, and employees, (the Releasees hereon) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, and I further agree that if, despite the release and waiver of liability, assumption of risk and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damages, or cost which may incur as the result of such claim. I have read this Agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. For Minors: And I, the Minor's parent and/or legal guardian, understand the nature of activities and the Minor's experience and capabilities and believe the Minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless each of the Releasees from all liability, claims, demands, losses, or damages on the Minors account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations and further agree that if, despite this release, I, the Minor, or anyone on the Minors behalf makes a claim against any of the Releasees named above, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss liability, damage, or cost may incur as the result of any such claim. For valuable consideration given and which is hereby acknowledged, the undersigned hereby grant to the Bay County Civic Arena permission to take or have taken still and moving photographs and films including television pictures of me, my son, daughter, or ward. I/we consent and authorize Bay County to use and reproduce photographs and films. With respect to the foregoing, no inducements or promises have been made to me/us to secure my/our signature(s) to this release other than the intention of Bay County to use such photographs or films for the purpose of promoting and aiding Bay County in their work.
