A PROPOSAL TO RENEW EXTRA VOTED MILLAGE FOR PURCHASING OF FIRE FIGHTING EQUIPMENT

Shall the previously voted increase in tax limitation imposed under Article IX, Section 6, of the Michigan Constitution on general ad valorem taxes within Garfield Township be renewed at ½ mill (\$0.50 per \$1,000.00 of taxable value) for the period of four (4) years from December 1, 2012 through December 1, 2015, both inclusive for the purpose of purchasing fire fighting equipment for the Garfield Township Fire Department, and shall the Township levy such renewal in millage for that purpose, thereby raising in the first year an estimated \$21,500.00?

FIRE DEPARTMENT EQUIPMENT MILLAGE RENEWAL

Shall the tax limitation on general ad valorem taxes within Mt. Forest Township, Bay County, Michigan imposed under Article IX, Section 6 of the Michigan Constitution be renewed for said Township at the current amount not to exceed 1.0 mill (\$1.00 on each \$1,000.00 of taxable value) for a period of nine (9) years, 2012 to 2020 inclusive, for purchasing equipment and vehicles for the fire department; and shall the Township levy such millage renewal for said purpose. thereby, raising in the first year an estimated \$29,997.98?

BAY COUNTY GYPSY MOTH SUPPRESSION PROGRAM

Shall the limitation of the amount of property taxes which may be levied each year against all taxable real and personal property in the County of Bay be increased by not more than .1 of a mill (10¢ per \$1,000) for a period of 4 vears, 2012 to 2015 inclusive, to continue suppression, public education, and monitoring of Gypsy Moths, Emerald Ash Borer and other invasive, non-native pests that damage local horticulture (trees and plants)? This is a renewal of the .1 of a mill approved by the voters in 2008 that expired in 2011. This millage will raise estimated revenues of \$290,196.78 in the first year of levy.

A PROPOSAL TO RENEW EXTRA VOTED MILLAGE FOR FIRE PROTECTION

Shall the previously voted increase in tax limitation imposed under Article IX, Section 6, of the Michigan Constitution on general ad valorem taxes within Garfield Township be renewed at 1 mill (\$1.00 per \$1,000.00 of taxable value) for the period of four (4) years from December 1, 2012 through December 1, 2015, both inclusive for the purpose of operating the township fire department and maintaining the fire hall, and shall the Township levy such renewal in millage for that purpose, thereby raising in the first year an estimated \$43,000.00?

A PROPOSAL TO RENEW VOTED MILLAGE FOR OPERATIONS, MAINTENANCE, AND EQUIPMENT FOR THE KAWKAWLIN TOWNSHIP FIRE DEPARTMENT

Shall the previously voted increase in the tax limitation imposed under Article IX, Section 6, of the Michigan Constitution on general ad valorem taxes within Kawkawlin Township be renewed to 1 (one) mill (\$1.00 per \$1,000.00 of taxable value) for a period of four (4) years from December 1, 2012 through December 1, 2015 both inclusive for the purpose of operation, maintenance and equipment for the Kawkawlin Township Fire Department, and shall the Township levy such a renewal in millage for that purpose, thereby raising in the first year an estimated \$140,000.00?

A PROPOSAL TO RENEW EXTRA VOTED MILLAGE FOR FIRE PROTECTION

Shall the previously voted increase in the tax limitation imposed under Article IX, Section 6, of the Michigan Constitution on general ad valorem taxes within Fraser Township be renewed at 1 mill (\$1.00 per \$1,000.00 of taxable value) for the period of four (4) years from December 1, 2012 through December 1, 2015 inclusive, for the purpose of operating the Township fire department, maintaining the fire hall, and purchasing necessary fire fighting equipment, and shall the Township levy such renewal in millage for said purposes, thereby raising in the first year an estimated \$89,566.00?

OPERATING MILLAGE RENEWAL PROPOSAL

This proposal will allow the school district to continue to levy the statutory rate of 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance. The remaining .95 mill is only available to be levied to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963 and will only be levied to the extent necessary to restore that reduction.

Shall the limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Standish-Sterling Community Schools, Arenac, Gladwin and Bay Counties, Michigan, be increased by 18.95 mills (\$18.95 on each \$1,000 of taxable valuation) for a period of 10 years, 2013 to 2022, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and levied in 2013 is approximately \$1,830,000 (this is a renewal of millage which will expire with the 2012 tax levy)?

A PROPOSAL TO RENEW EXTRA VOTED MILLAGE FOR FIRE PROTECTION

Shall the previously voted increase in the tax limitation imposed under Article IX, Section 6, of the Michigan Constitution on general ad valorem taxes within Gibson Township be renewed at 1 mill (\$1.00 per \$1,000.00 of taxable value) for the period of three (3) years from December 1, 2012 through December 1, 2014 inclusive for the purpose of providing fire fighting services, and shall the Township levy such renewal in millage for that purpose, thereby raising in the first year an estimated \$27,000?

FIRE DEPARTMENT OPERATING MILLAGE RENEWAL

Shall the Charter Township of Bangor continue to levy a real and personal property tax in an amount not to exceed .65 mills (\$.65 per \$1,000.00 of taxable value) for a period of six (6) years, 2012 to 2017 inclusive, for fire department purposes which, if levied, will raise an estimated \$283,207.00 in the first year of such levy?
