CITIZEN INPUT

CHAIRMAN ELDER OFFERED TO ACCEPT COMMENTS OF CITIZENS WISHING TO ADDRESS THE BOARD WITH THEIR CONCERNS.

NO ONE CAME FORWARD TO ADDRESS THE BOARD AT THIS TIME.

PETITIONS AND COMMUNICATIONS

HOWARD WETTERS, MSU DIRECTOR, INTRODUCED DEANNE EAST, AS THE NEW MICHIGAN STATE UNIVERSITY EXTENSION (MSUE) DISTRICT 9 COORDINATOR. HE SAID AS OF JULY 1, 2010 THE RESTRUCTURING IS IN PLACE AND THAT BAY COUNTY IS LOOKING FORWARD TO WORKING WITH MS. EAST.

MS. EAST GAVE A BRIEF UPDATE OF THE STATE-WIDE RESTRUCTURING OF MSUE. SHE STATED THE REDESIGN PRINCIPLES INCLUDE: FOCUSED AND SPECIALIZED PROGRAMMING; REDUCED ADMINISTRATIVE OVERHEAD; INCREASED RESPONSIVENESS: ENHANCED ACCOUNTABILITY: CONTINUED PRESENCE ACROSS THE STATE; AND ADOPTION OF EMERGING TECHNOLOGIES. MS. EAST SAID OTHER FEATURES OF THE REVISED ADMINISTRATIVE STRUCTURE INCLUDE: CONSOLIDATING BUDGET AND PERSONNEL FUNCTIONS IN ONE ON-CAMPUS BUSINESS OFFICE; 13 MULTI-COUNTY DISTRICTS, EACH OVERSEEN BY ONE DISTRICT COORDINATOR; AND COMMUNITY PARTNERSHIPS. IN CONCLUSION SHE SAID, THE REDESIGN OF MSUE IS DRIVEN BY A DESIRE TO REALLOCATE RESOURCES TO INCREASE PROGRAMMING ACROSS THE STATE WHILE REDUCING ADMINISTRATIVE OVERHEAD. SHE SAID THE RESTRUCTURE WILL ALLOW US TO BE MORE EFFICIENT AND RESPONSIVE TO THE ECONOMIC NEEDS OF MICHIGAN.

COMM. COONAN ASKED IF ALL THE MSUE PROGRAMS ARE PRESENTLY IN PLACE AND MS. EAST SAID YES.

TILLEY MOVED TO ADOPT RES. 2010-139 URGING THE PRESIDENT, CONGRESS, AND THE FEDERAL COMMUNICATIONS COMMISSION OF THE UNITED STATES TO REFRAIN FROM REGULATING INTERNET BROADBAND SERVICES AS COMMON CARRIER SERVICES UNDER TITLE II OF THE COMMUNICATIONS ACT OF 1934. FURTHER, THAT A COPY OF THIS RESOLUTION BE SENT TO THE PRESIDENT OF THE UNITED STATES, THE PRESIDENT OF THE U.S. SENATE, THE SPEAKER OF THE U.S. HOUSE OF REPRESENTATIVES, THE MEMBERS OF THE MICHIGAN CONGRESSIONAL DELEGATION; AND THE FEDERAL COMMUNICATIONS COMMISSION. IT WAS SUPPORTED BY COMM. GWIZDALA FOR DISCUSSION.

COMM. COONAN SAID RES. 2010-139 DOES NOT ACKNOWLEDGE THE LONG TIME DIVISION AMONG THE NUMBERS OF BROADBAND INTERNET ENTITIES. A SMALL GROUP OF TELECOM AND INTERNET

SERVICE PROVIDERS HAVE THE ABILITY AND USED THAT ABILITY TO ALTER THE DOWNLOAD SPEEDS OF INTERNET CUSTOMERS. COMPANIES AND CONSUMERS AFFECTED HAVE REQUESTED THE FCC ADDRESS THIS DISPUTE. THE FCC, WHICH IS THE REGULATORY AGENCY FOR BROADBAND INTERNET, SOUGHT TO REMEDY THIS DISPUTE. THEY SANCTIONED COMCAST WHICH WAS APPEALED IN COURT. PRESENTLY, THE FCC IS IN THE PROCESS OF TAKING PUBLIC INPUT ON THIS MATTER. THEIR RECOMMENDATIONS WILL BE BROUGHT TO CONGRESS TO SEE IF THERE IS A REMEDY. COMM. COONAN SAID IN HIS OPINION, TO SUPPORT THIS RESOLUTION IS A VOTE FOR STATUS QUO. IF THIS RESOLUTION IS APPROVED, WE ARE TELLING CONGRESS THERE IS NO PROBLEM IN THE BROADBAND INDUSTRY AND THAT IS NOT THE CASE. HE SAID HE WOULD NOT SUPPORT THIS RESOLUTION.
