

## UNCLAIMED BAY COUNTY CHECKS

---

To insure that every individual receives the money from a check(s) that was written to them, the County Treasurer is posting the list of unclaimed checks showing individuals who were sent a check from Bay County but the issued check was never cashed.

If your name appears on the list please call the treasurers office at (989) 895-4285. You will need to identify yourself and answer questions that will help us verify that you are the person to whom the money should go to. Upon completion of the necessary documentation a new check will be sent to you.

### LIST OF UNCLAIMED CHECKS

AS OF June 30, 2025

The law (Public Act 29 of 1995) regarding unclaimed property (including check) has been re-written to shorten the time to one year before items must be turned over to the State of Michigan. After you have checked out the list on the Bay County's site, you may want to check the State of Michigan Department of Treasury Unclaimed Property to determine if they are holding anything that might belong to you.
