CITY OF PINCONNING PROPOSAL

Public Safety Millage

Shall the City of Pinconning levy 3- mills, in addition to all authorized millages by State Law and City Charter on real and personal property subject to tax limitation in the city for a period of five (5) years beginning with the 2026 tax levy and running through 2030 tax levy year, to be used for the sole and exclusive purpose of providing for operation, purchase of equipment, housing of Pinconning City Police and Pinconning Fraser Fire Department personnel, paying wages, salaries and cost for operation of those departments from said millage as well as other funds available to the city, including purchase of all equipment, supplies, and sundry items which may be used during the course of the year for Police and/or Fire Department protection and use. If approved, this would be a new authorized millage and appear on your tax bill and is not a renewal of your existing millage which is set to expire in 2025 after the 2025 collection.

FRANKENLUST TOWNSHIP PROPOSAL

Fire Department Personnel Expense Millage

Shall Frankenlust Township adopt a new millage in an amount not to exceed 0.5 mills (0.5 mills equals 1/2 mills which equals fifty cents on each one thousand dollars of taxable value) as provided for by Section 6, Article IX of the 1963 Constitution of Michigan on all real and personal property within the Township of Frankenlust and levy it for a period 5 year(s) to be collected in December 2026-2032 inclusive for use as wages and personnel expenses only for the Township Fire Department, which will raise an estimated \$93,369.46 in the first year that the millage is levied.

The estimate of the revenue the Township will collect in the first year (2027) if the millage is approved and levied by the Township is approximately \$140,000.

MERRITT TOWNSHIP PROPOSAL

Renewal Road Millage Proposal

Shall Merritt Township levy up 1.5 mills (\$1.50 per \$1000.00 of Taxable value) above the tax limitation imposed under Article IX, Section 6, of Michigan Constitution, and levy it for five years, December 1, 2026 through December 1, 2030 inclusive, for the purpose of raising revenues for the maintenance and improvements of public Roads in Merritt Township, raising an estimated \$118,130.00 in the first year the millage is levied? If approved, this proposal constitutes a renewal of the previously voted millage within Merritt Township which will otherwise expire on December 1, 2026.

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2027 is 2.35 mills (\$2.35 on each \$1,000 of taxable valuation). The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-one (21) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 3.91 mills (\$3.91 on each \$1,000 of taxable valuation).

(Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

FREELAND COMMUNITY SCHOOL DISTRICT PROPOSAL**Freeland Community School District
Operating Millage Renewal Proposal**

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance. The remaining .2837 mill is only available to be levied to restore millage lost as a result of the reduction required by the Michigan Constitution of 1963 and will only be levied to the extent necessary to restore that reduction.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Freeland Community School District, Saginaw, Midland and Bay Counties, Michigan, be renewed by 18.2837 mills (\$18.2837 on each \$1,000 of taxable valuation) for a period of 8 years, 2027 to 2034, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2027 is approximately \$2,435,134 (this is a renewal of millage that will expire with the 2026 tax levy)?
